The stakeholder process involved analysis of parent and teacher surveys to develop plan components, staff input meetings, General Parent meetings, Coffee with the Principal, Plan review and input by the District English Learner Advisory Committee and School Site Council (DELAC, SSC), Lashon Academy City Governing Board Meeting and Public Hearing and Lashon Academy City Governing Board Meeting. Spanish translation was made available when needed to communicate with families to maximize opportunities for feedback and paper copies of the plan have been made available at the office for those without internet access.

Utilizing stakeholder feedback is an essential part of ensuring programs and services offered to meet the needs of all families are in line with our school community. The following ideas and trends used in the development of our plan were influenced by the community input we received. Parent Survey and feedback focused on the need for the school to provide intensive intervention supports and a more robust social/emotional program for students. Most families expressed the support of para-educators in the classrooms to assist students and teachers. Staff and parents reported a high level of need for all covid personal protective gear in addition to covid safety protocols to be in place and monitored to provide for a safe and healthy learning environment. Stakeholders also expressed the desire for a two-way communication tool with the support of language translation.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
