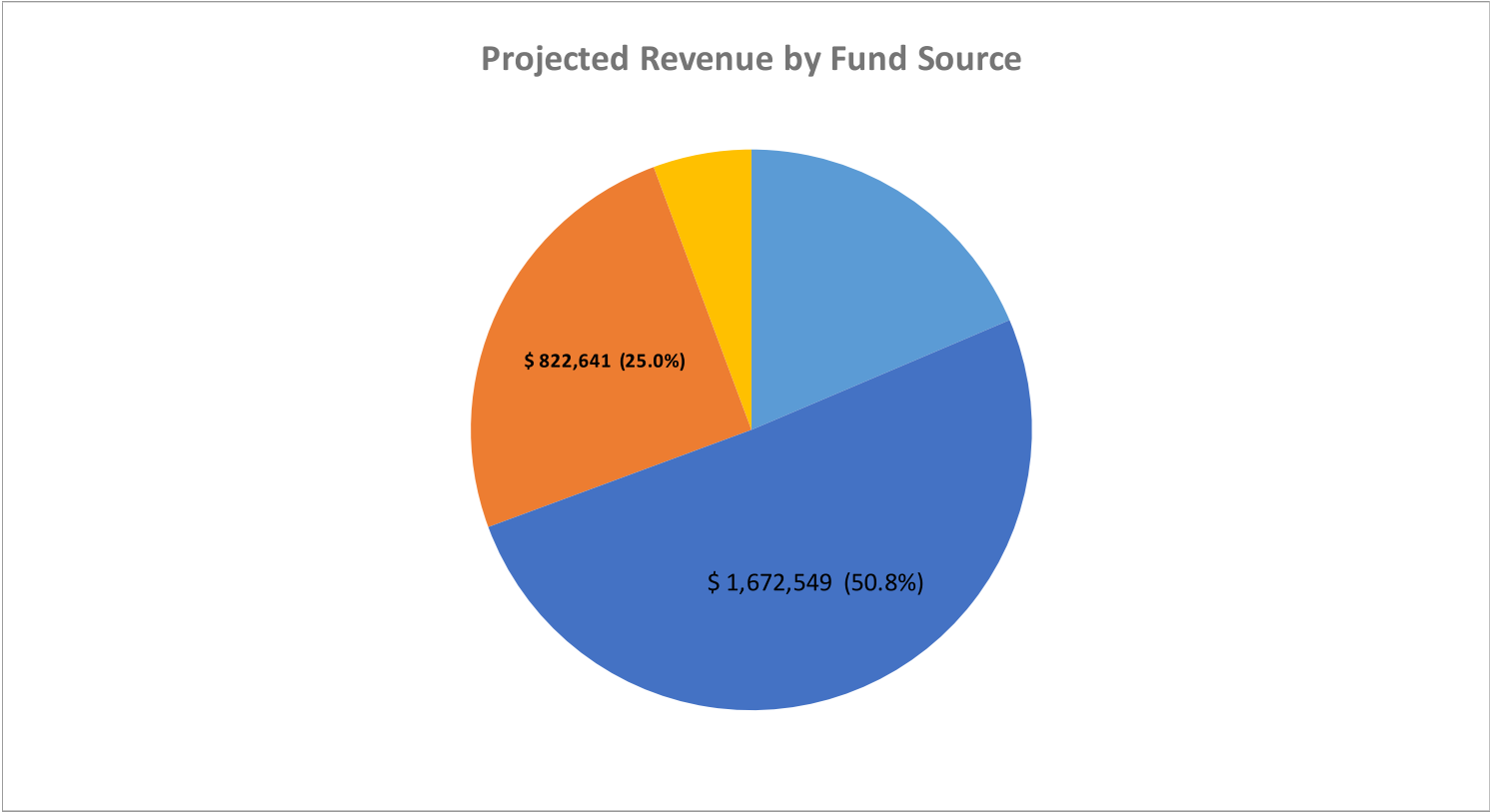

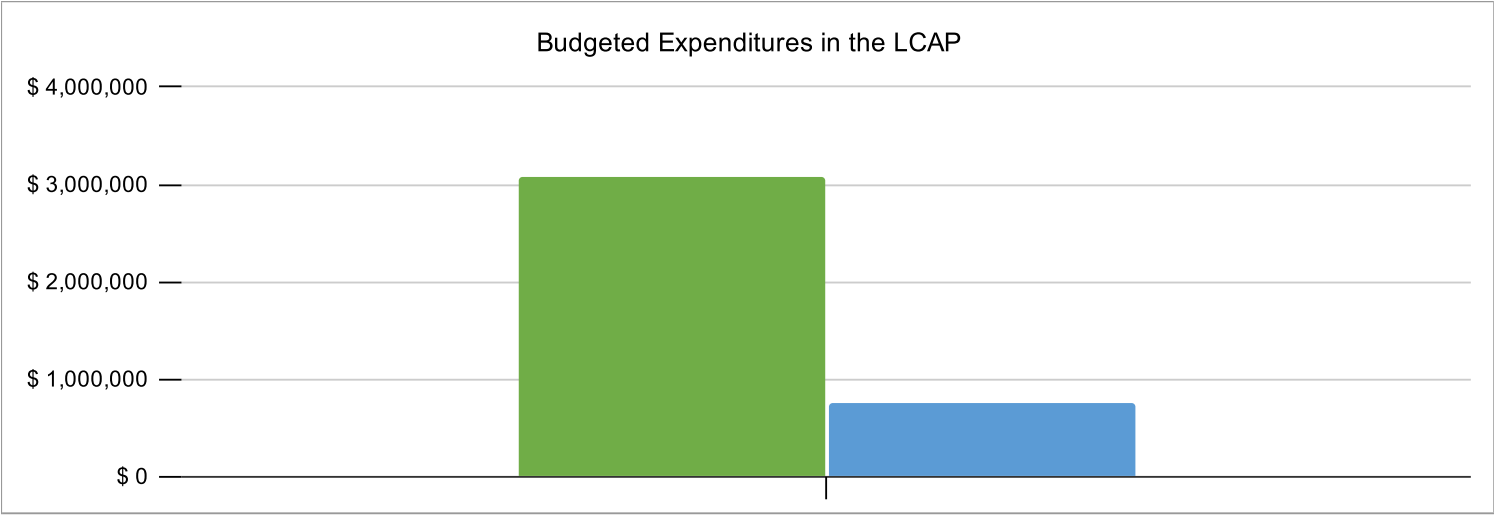
Budget Overview for the 2026-27 School Year

The text description for the above chart is as follows: The total revenue projected for Lashon Academy City is \$3,294,501.00, of which \$2,285,231.00 is Local Control Funding Formula (LCFF), \$822,641.00 is other state funds, \$0.00 is local funds, and \$186,629.00 is federal funds. Of the \$2,285,231.00 in LCFF Funds, \$612,682.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

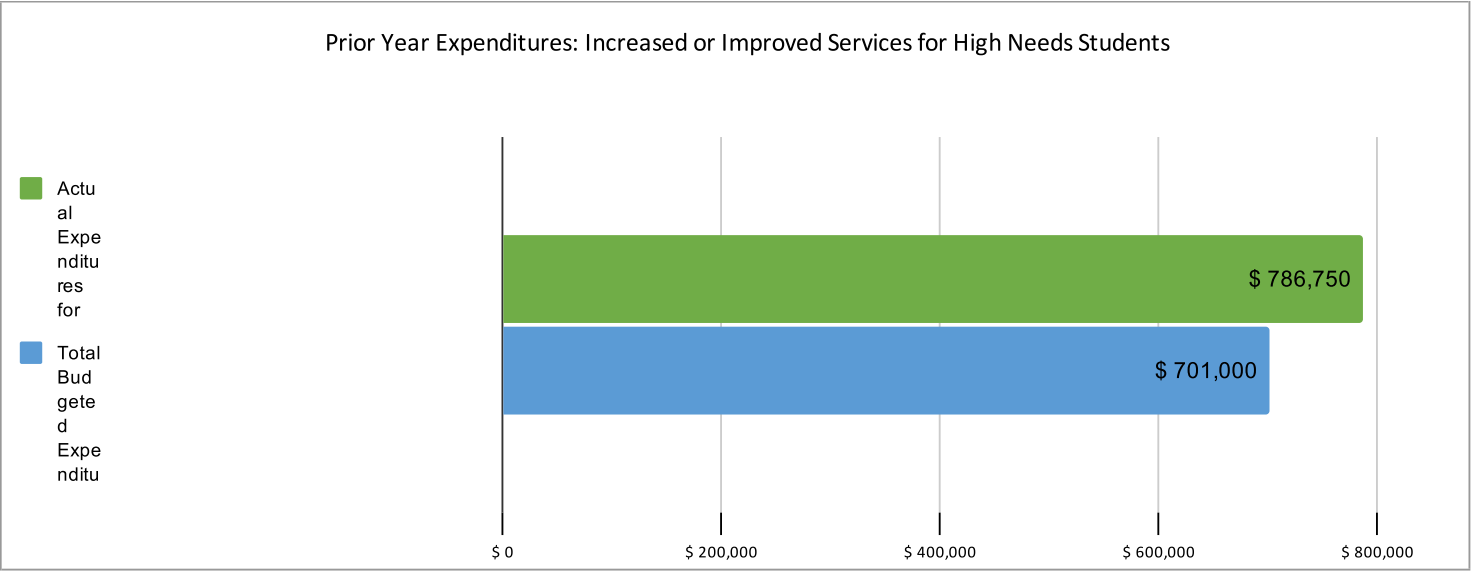

Plan Summary 2026-2027

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Lashon Academy City is an approved charter school that operates as an independent elementary charter school, offering instruction in grades TK-6 serving families and their children in Mid-City and the greater Los Angeles community. Lashon Academy City is modeled after its sister school, Lashon Academy, a high-performing LACOE-authorized charter school serving students from a broad geographical range in the San Fernando Valley.

Lashon Academy City successfully serves all students, including English Learners, students with disabilities, socioeconomically disadvantaged students, gifted students and students achieving below grade level. Lashon Academy City is committed to ongoing and embedded professional development to ensure the quality delivery of instruction to its students. Lashon Academy City delivers the highest caliber educational program within a fiscally sustainable school.

The Lashon Academy City mission is to prepare culturally diverse TK-6th grade students to be self-directed learners and responsible global citizens by fostering academic excellence and utilizing research-based instructional approaches in a multilingual and service learning integrated environment.

In the 2024 – 2025 school year, Lashon Academy city served 127 students TK-6 students. Our diverse community was comprised of 92.1% students who were socioeconomically disadvantaged, 31.5% students designated as English Learners, 6.3% Students with Disabilities, 17.3% students who identified as Black/African American, 1.6% students who identified as Asian, 1.6% students who identified as Two or More Races, 0.8% students who identified as White, and 78.7% students who identified as Hispanic/Latino.

The purpose of this Local Control Accountability Plan (LCAP) is to address the School Plan for Student Achievement (SPSA) for Lashon Academy City which is the Schoolwide Program; herein referred to as the LCAP. The Charter School's plan is to effectively meet the ESSA Requirements in alignment with the LCAP and other federal, state and local programs. The Charter School completed a comprehensive needs assessment of the entire school which included an analysis of verifiable state data and local performance data used to measure student outcomes as evidenced in the annual update portion of the LCAP. The needs assessment process included meeting parents, classified staff, teachers and administrators to identify areas of opportunity for the students and groups of students who are not achieving standard mastery and to identify strategies which will be implemented in the LCAP to address those areas of opportunity. Each goal includes actions and services that address the needs of all students and significant subgroups which include evidence-based strategies that provide

opportunities for all children, methods and instructional strategies, and particular focus on students at risk of not meeting the State academic standards.

Lashon City Academy does not receive Equity Multiplier funding.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

This annual performance review, based on the California School Dashboard (Dashboard) and local data, highlights meaningful academic growth and improved student outcomes at Lashon Academy City. While the school does not receive color-coded indicators due to its small TK–6 enrollment, 2025 results reflect strong gains in English Language Arts, steady improvement in Mathematics, and notable progress in English language development. Chronic absenteeism rates declined significantly, and suspension rates remained at 0% for a second consecutive year—demonstrating the effectiveness of the school’s academic and social-emotional support systems.

These outcomes reflect the impact of targeted interventions, enhanced instructional practices, and a supportive school environment focused on the success of all students. Despite this progress, continued attention is needed to address persistent gaps and ensure every student achieves academic success.

Dashboard Performance

English Language Arts (ELA): Overall increase by +12.7 points. Notable growth and increase in Socioeconomically Disadvantaged (+12.7 points).

Mathematics: Overall decrease by -14.2 points.

English Language Proficiency Indicator: Decrease by -11.6% with 52.0% making progress towards English Language proficiency.

Chronic Absenteeism: Overall increase by +1.5% from 2024. Substantially outperforming the states overall rate of 17.1%.

Suspension Rates: Maintaining suspension rates of 0% and blue indicator for a second consecutive year.

Local Indicators: All state-required local indicators were met.

Additional Dashboard Data: Informational Purposes

CA Growth Model ELA: Students in the *all students* group demonstrated growth classified as “Exceptional”, 75% of students improved their score from the prior year . Additionally, all student groups (English Learners, Hispanic and Socioeconomically Disadvantaged) scored in the “exceptional” growth category. These outcomes reflect the effectiveness of targeted supports and instructional strategies for historically underserved student groups.

CA Growth Model Math: Students in the *all students* group demonstrated growth classified as "Accelerated", 82.1% students improved their score from the prior year . Additionally, all student groups growth was either “Exceptional or Accelerated” with English Learners (93.8% improvement), Hispanic students (91.3% improvement), and Socioeconomically Disadvantaged students (82.1% improvement). These outcomes reflect the effectiveness of targeted supports and instructional strategies for historically underserved student groups.

Lowest Performing Student Groups

Lashon Academy does not have any red indicators on the 2024 Dashboard schoolwide or for any student groups.

Learning Recovery and Emergency Block Grant

Lashon Academy City has a total LREBG allocation of \$74,074 to be used over three years. We have used it all in the 25/26 school year, which supported Goal 2, Action 3 (Evidence-Based ELA Instruction). This action aligns with EC 32526(c)(2) by funding targeted academic supports and professional development focused on literacy and language development. The funding addresses needs identified in Lashon Academy City’s assessment, including persistent achievement gaps among English Learners and low-income students, through differentiated instruction, small-group intervention, and the implementation of a standards-aligned curriculum.

Lashon Academy City is committed to involving its educational partners in the input and development of the school's LCAP. We value all input and use this input to help prioritize needs, safety measures, instruction and growth goals. The planning and engagement process included several steps involving our School Site Council (SSC), staff, District English Language Advisory Council (DELAC), Parent Teacher Organization (PTO), and parent/student/staff feedback surveys. The educational partner engagement process includes administering surveys to students, staff, and parents throughout the year to get feedback from all partners.

In addition, we want to be as proactive as possible with our parent meeting communication. At the start of the school year, we share a parent meeting calendar with all parents. We also schedule all dates within the parent events calendar on our communication platform Parentsquare so all parents receive reminder notifications about the meeting dates and times. Meetings were offered in alternating months in response to parent feedback, to provide greater flexibility and accessibility for all families. School Site Council and DELAC Meetings held on 10/30/25, 2/5/26, and 5/14/26. These meetings were held virtually with a Google Meet Link and in-person at the school site. Based on feedback from our initial parent survey, we continued to offer our parent meetings with alternating start times between mornings at 9am and nights at 7pm to allow more access for those working parents. Spanish translation was also offered at every meeting.

Teachers	Lashon Academy City involves teachers in the development of the LCAP through a structured process that includes surveys, focus groups, and regular review meetings, starting from initial planning in August to final board approval in June. Monthly check-ins and workshops ensure continuous teacher engagement, while public meetings and feedback forms provide additional opportunities for input.
Principals/Administrators	Lashon Academy City engages administrators in the LCAP development through a timeline that includes initial planning in August, information gathering via surveys and focus groups in the fall, and collaborative drafting and review sessions in the winter and spring. Regular bi-monthly meetings and strategy workshops ensure continuous input and alignment with administrative priorities. Administrators provide feedback during public meetings, and their insights are incorporated into the final revisions before board approval in June. This inclusive process emphasizes collaboration, values administrators' leadership expertise, and ensures transparent communication throughout.
Students	Lashon Academy City involves students in the LCAP development through a process starting with student climate surveys in the fall to gather input on their needs and priorities. Student Council and groups meet throughout the year to discuss findings and provide feedback. School-wide assemblies and 2nd climate survey in the spring allow for broader student engagement and final input before the plan is finalized and presented for board approval in June.

Parents	Lashon Academy City engages parents in the development of the LCAP through a yearlong timeline that begins with surveys and outreach in the fall to gather input on parent priorities and concerns. Ongoing engagement includes regular School Site Council (SSC) and District English Learner Advisory Committee (DELAC) meetings, as well as focus groups and “Coffee with the Administrator” sessions to review findings and incorporate parent feedback. Additional strategies include bilingual workshops, online feedback tools, and targeted outreach to underrepresented parent groups to ensure a broad and inclusive range of perspectives. This collaborative approach values parental input, fosters transparency, and ensures that family voices help shape the LCAP. Engagement meetings were held on October 30, 2025, February 5, 2026, and May 14, 2026, with options to attend either virtually via Google Meet or in person at the school site.
LACOE SELPA	Throughout the year, SELPA representatives participate in regular communication, and the Lashon team attends SELPA meetings to provide detailed feedback and ensure alignment with special education goals. This collaborative approach values SELPA's expertise, promotes inclusive planning, and ensures that the needs of special education students are integral to the LCAP.

Lashon Academy City’s adopted LCAP reflects meaningful input from a broad range of educational partners, including families, students, staff, and advisory groups. Feedback gathered through surveys, advisory meetings, and stakeholder forums directly informed the development of goals, metrics, and actions across the plan.

Educational partners emphasized the importance of improving academic outcomes, leading to strengthened data practices such as expanded use of internal assessments, teacher collaboration on data analysis, and targeted intervention supports. Parents also voiced the need for a clean and safe campus, which informed investments in regular facility inspections and site improvements.

To support educator effectiveness, the LCAP includes actions focused on recruitment, retention, and professional learning, especially for staff serving unduplicated pupils. Parent engagement remained a clear priority, prompting increased access to meetings, flexible scheduling, multilingual communication, and expanded use of digital tools.

Educational partners also underscored the need for a positive school culture and stronger attendance. In response, the LCAP includes implementation of PBIS, restorative practices, and a multi-tiered attendance campaign with family outreach and student recognition.

By integrating this feedback, the LCAP reflects a community-driven approach that aligns with the values and priorities of Lashon’s educational partners.

Goal Analysis for 2025-2026

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Lashon Academy City demonstrated steady progress toward creating and promoting a safe, clean, and mission-aligned learning environment with highly qualified personnel, standards-aligned curriculum and materials, and a robust academic program with the integration of technology.

Successful Implementation: Action 1.2 (Qualified Personnel): Implemented a rigorous hiring process focused on mission alignment and monitored staff assignments to meet the needs of unduplicated pupils. As a result, the school successfully maintained its baseline of 100% of teachers meeting or exceeding qualification standards. Action 1.3 (Technology Access & Integration): Achieved 1:1 student device access and successfully integrated technology into instruction with regular usage monitoring. Year 2 data shows that 100% of students regularly utilized technology as part of their learning experience, maintaining the school's baseline performance. Action 1.4 (Safe and Clean Campus): Maintained clean, safe facilities through routine inspections and targeted custodial support in high-use areas. Facility inspections for Year 2 revealed that 100% of facilities met cleanliness and safety standards, marking a +1.39% improvement over the baseline of 98.61%. Action 1.5 (Curriculum and Materials): Conducted a comprehensive review and updated materials to ensure full alignment with standards and instructional goals. The school successfully maintained its 100% rate of classrooms utilizing standards-aligned curriculum and instructional materials.

Implementation Challenges: Action 1.1 (Teacher Training): While BTSA and mentorship supports were offered to new teachers, the inconsistent availability of mentor teachers limited full program participation for some new staff members.

Note: No actions were modified or left unimplemented. Overall, these efforts effectively contributed to a safe, clean, and high-quality academic environment that directly supported improved student outcomes.

There were no material differences between budgeted and estimated actual expenditures, nor between planned and estimated actual percentages of improved services for the 2025–26 school year. Expenditures and services were implemented as planned in alignment with the goals and actions outlined in the LCAP.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The specific actions implemented under Goal 1 were highly effective in achieving the targeted year-end outcomes: The rigorous hiring process (Action 1.2) ensured that staff competency stayed at maximum capacity (100%). Equitable tech distribution (Action 1.3) successfully secured complete digital access for all student groups. The structured maintenance schedule (Action 1.4) elevated the campus environment, bringing facility health up to a perfect 100% rating. Regular curriculum audits (Action 1.5) verified that every student retained access to high-quality, standards-aligned instructional materials both at home and at school.

As a result of reflections on prior practice and the positive outcomes of Year 2 data, no changes or substantive modifications have been made to the planned goal, metrics, target outcomes, or actions for the upcoming school year. Goal Analysis for 2025-2026

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Lashon Academy City made substantial progress in implementing the planned actions under Goal 2 to strengthen instructional practices and support the academic growth of English Learner and unduplicated students.

Successful Implementation: Action 2.1 (Professional Development): All instructional staff participated in professional development focused on CCSS implementation, small group instruction, data use, and differentiation. Year 2 data confirms that 100% of teachers participated in at least 6 professional development sessions per year, maintaining the baseline standard. Action 2.2 (Targeted English Language Intervention) & Action 2.3 (Evidence-Based ELA Instruction): Targeted ELD interventions and evidence-based instructional practices were implemented with fidelity, aligned to student needs and language development goals. Classroom observations during Year 2 revealed that 100% of teachers effectively implemented at least three new instructional strategies learned during PD, representing a +22% increase over the baseline of 78%. Furthermore, California Dashboard data indicates that 52.0% of English Learners made progress toward English language proficiency, representing a +24.7% increase over the 27.3% baseline. Action 2.4 (English Learner Support / Family Engagement): The

school successfully engaged families of unduplicated pupils by providing literacy-focused resources and workshops to help them support learning at home, strengthening the connection between school and family. Action 2.5 (Classroom Support / Coaching): Teachers received ongoing coaching and support aligned to their student population, helping reinforce best practices in classrooms serving unduplicated pupils.

Implementation Challenges:

All planned actions were implemented as intended, with no substantive deviations. Continued development of coaching systems and deeper family engagement remain priorities for ongoing improvement.

There were no material differences between budgeted and estimated actual expenditures, nor between planned and estimated actual percentages of improved services for the 2025–26 school year. Expenditures and services were implemented as planned in alignment with the goals and actions outlined in the LCAP.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The actions implemented under Goal 2 proved highly effective. Schoolwide professional development (Action 2.1) and classroom support (Action 2.5) directly translated to maximum strategy adoption (100%) during instructional observations. This high level of implementation fidelity directly supported English Learner growth, resulting in over half of the EL student population (52.0%) actively demonstrating progress toward English proficiency on the state dashboard.

Goal Analysis for 2025-2026

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Lashon Academy City successfully implemented all planned actions under Goal 3 to support student academic growth and proficiency across core content areas. The school focused on data-informed instruction, targeted interventions, and structured support systems for English Learners and unduplicated pupils.

Successful Implementation:

Action 3.1 (Targeted Instruction and Intervention): Instructional strategies were aligned to CAASPP data analysis, with targeted support provided to English Learners, low-income students, and foster youth. Intervention blocks and small group instruction were integrated into the schedule and responsive to subgroup needs. State testing participation remained exceptional, as the school successfully maintained its 100% participation rate on the CAASPP for the third consecutive year.

Action 3.2 (Data-Driven Instruction): The school established a strong data culture with regular team meetings and structured analysis of student performance. Data protocols helped inform instructional planning, identify learning gaps, and develop action steps for improvement. While Year 2 CAASPP proficiency rates experienced a decline—with overall ELA proficiency dropping to 36.58% (English Learners at 0.00%, Socioeconomically Disadvantaged at 36.58%, and Hispanic students at 34.38%) and overall Math proficiency decreasing by -14.2 points on the Dashboard —internal data reveals strong growth trajectories.

Internal Growth Metrics (i-Ready): Year 2 internal benchmark assessments demonstrate highly successful instructional impact, with 58% of all students meeting growth goals in ELA (a +9.6% increase over baseline). Subgroup growth in ELA was also outstanding: English Learners grew by +10.8% (reaching 59%), Socioeconomically Disadvantaged students grew by +19.5% (reaching 61%), and Hispanic students grew by +13.1% (reaching 56%). Furthermore, the California Growth Model classified student growth as "Exceptional" in ELA (with 75% of students improving their score) and "Accelerated" in Mathematics (with 82.1% of students improving their score).

Action 3.3 (Support for Unduplicated Pupils): Students received additional instructional support in ELA and Math, including small group time, supplemental materials, and intervention-based planning tied to ongoing assessment results.

Implementation Challenges: All planned actions were implemented as intended, with no substantive deviations. Aligning standard mastery on state testing with internal growth indicators remains an ongoing focus area for instruction.

There were no material differences between budgeted and estimated actual expenditures, nor between planned and estimated actual percentages of improved services for the 2025–26 school year. Expenditures and services were implemented as planned in alignment with the goals and actions outlined in the LCAP.

The implementation of targeted instruction (Action 3.1) and data-driven instruction (Action 3.2) proved highly effective in fostering student learning acceleration, as evidenced by the "Exceptional" and "Accelerated" designations in the California Growth Model. While absolute proficiency percentages on the CAASPP fluctuated , the high rates of student growth on local i-Ready diagnostic diagnostics (reaching up to 61% growth for low-income subgroups) validate that the school's intervention structures are successfully closing educational gaps.

Reflections on current practice and implementation experiences led to minor modifications to ensure consistency in reporting and analyzing goals, actions, and metrics. Goal Analysis for 2025-2026

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

During the 2025–2026 school year, Lashon Academy City successfully implemented all planned actions under Goal 4 to promote a positive school culture, increase parent engagement, and support student attendance and behavior. The school focused on building inclusive practices and responsive systems that address the needs of all students, including unduplicated pupils and students with disabilities.

Successful Implementation:

Lashon Academy City Local Control and Accountability Plan 2026-2027

Action 4.1 (Parent Engagement): The school hosted regular workshops and informational sessions on academic support, wellness, and school programs. Targeted outreach strategies, including multilingual communication and translation services, ensured inclusive parent participation, particularly among families of English Learners and other unduplicated students. Local data tracking reveals the successful execution of four school-wide events (including the Fall/Spring Showcase, a dance show, and a Science Fair), alongside two targeted technology/Reflex workshops, and two formal parent meetings.

Action 4.2 (Attendance Awareness): An attendance awareness campaign was launched, supported by ongoing monitoring of attendance trends. This initiative yielded exceptional results, as the schoolwide Average Daily Attendance (ADA) rate rose to 98.04% (marking a +1.33% increase from the baseline). Attendance rates across unduplicated student groups were equally strong, with English Learners reaching an ADA of 98.51% (+0.57% over baseline) and Socioeconomically Disadvantaged students achieving 98.06% (+1.32% over baseline). Furthermore, chronic absenteeism rates declined significantly, substantially outperforming the statewide average of 17.1%.

Action 4.3 (Positive School Climate & PBIS Implementation): Disciplinary data was regularly reviewed to monitor equity in behavior interventions. The school-wide implementation of the PBIS framework directly contributed to a safe, positive campus culture, as evidenced by a continued suspension rate of 0%, allowing the school to maintain its "Blue" dashboard indicator for a second consecutive year. This safe environment was validated by Year 2 student culture surveys, which revealed that 96% of students felt a strong sense of safety and 95% of students felt a strong sense of school connectedness on campus.

Implementation Challenges: While all actions were implemented as planned, a key challenge was balancing the frequency and accessibility of parent engagement events for working families. In response to this feedback, adjustments were made mid-year to offer sessions with alternating start times (mornings at 9:00 AM and evenings at 7:00 PM) and via virtual platforms like Google Meet, which effectively increased parent accessibility and participation.

Conclusion: Overall, Goal 4 actions contributed to a stronger sense of community, highly improved attendance rates, and a safe and inclusive learning environment for all students.

The actions implemented under Goal 4 proved to be highly effective. The attendance awareness campaign (Action 4.2) and close monitoring of student data pushed daily attendance above 98% across all major student groups, which directly mitigated chronic absenteeism. Simultaneously, the structured roll-out of the PBIS framework and restorative practices (Action 4.3) secured an unblemished 0% suspension rate and generated exceptionally high student perception marks, with over 95% of surveyed students reporting high levels of safety and school connectedness.
